SADS UK is pleased to be hosting the charity's **10th annual National Lifesaver Awards**. Over this time the charity has honoured people from all walks of life who've saved lives using CPR and the defibrillator. At the very first Lifesaver Awards we had the honour and pleasure of the company of Professor Douglas Chamberlain CBE who kindly presented the Lifesaver Awards. The charity was fortunate that he joined them again to present awards in 2011. Professor Chamberlain, Cardiologist, founded the first paramedic unit in Europe, revolutionising pre-hospital clinical care and was a founder member of the Resuscitation Council (UK), the European Resuscitation Council, and the International Liaison Committee on Resuscitation (first co-chairman). He has been principal author or co-author of over 250 papers on topics in cardiology and resuscitation medicine.

The Resuscitation Council (UK) have supported the Awards over the years, along with the College of Paramedics, St Johns Ambulance, Cardiologists, Chief Executives of Ambulance Trusts, Community Partnership Managers, Paramedics and other organisations and individuals prominent in the field of saving lives. Celebrities Dame Helen Mirren, Dr Christian Jessen and SADS UK Patron, Dr Hilary Jones supports the SADS UK Annual National Lifesaver Awards. SADS UK are also delighted that Sudden Cardiac Arrest Survivors also join us on these special occasions.
