## The SADS UK Big Shock Campaign

## Urging Government to bring in legislation to make defibrillators compulsory in schools

The National cardiac charity SADS UK places Automated External Defibrillators (AEDs) including training in schools and has been putting this potentially lifesaving equipment in place for the past 13 years. SADS UK has persuaded Policymakers at the Department for Education to add to the new guidance (April 2014) issued to schools; they now advise schools that modern defibrillators are easy to use, inexpensive and safe and ask them to consider purchasing a defibrillator as part of their first aid equipment. SADS UK is proud to have helped so many schools put defibrillators and lifesaving skills in place and continue to lobby Government to bring in legislation to make defibrillators compulsory in all schools.

In 2006 SADS UK gained much support from MPs from their Early Day Motions (EDMs) and their first Government e-petition in calling for defibrillators to be made compulsory in schools was welcomed by the public. In 2012 the charity, supported by the London Ambulance Service and West Midlands Ambulance Service delivered petitions signed by thousands of supporters to no. 10 Downing Street.





SADS UK works with Schools and Local Authorities to put defibrillators in place.

SADS UK works with ambulance services and the Resuscitation Council UK and can provide answers to questions people may have about the automated defibrillator. In latter years the technology refined, meaning that anyone can use the automated defibrillator and there is no chance of them doing any harm. The defibrillator makes the decision as to whether or not a therapeutic defibrillation shock is needed.
